

## Contest Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

- 1. Eligibility:** The *Hello, NFT World* hackathon (the "Contest") is subject to all applicable federal, state and local laws and regulations. Void where prohibited. Employees of Replit, Inc., ("Sponsor"), their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family and/or household members of each are not eligible.
- 2. Agreement to Rules:** By participating, you agree to be bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of Sponsor, as final and binding as they relate to the contest and any winning or payment.
- 3. Contest Period:** Entries will be accepted online starting on or about March 10, 2022 and ending April 7, 2022. All online entries must be received by April 7, 2022, 11:59PM PST, or when Sponsor declares the Contest ended (via an update to the date in these Rules), whichever occurs sooner.

The entry must fulfill all Contest requirements, as specified here, to be eligible to win. Entries that are not complete or do not adhere to the rules may be disqualified at the sole discretion of Sponsor. If you use fraudulent methods or otherwise attempt to circumvent the rules your submission may be removed from eligibility at the sole discretion of Sponsor.

- 5. Prizes; Odds:** One grand prize winning entry will receive \$25,000.00US and four runner-up winning entries will receive payment of \$5,000.00US per entry. No cash or

other prize substitution permitted except at Sponsor's discretion. The prize is non-transferable. Any and all prize related expenses, including without limitation any and all federal, state, and/or local taxes shall be the sole responsibility of the winner.

Acceptance of prize constitutes permission for Sponsor to use the winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law. The odds of winning depend on the number of eligible entries received.

- 6. Winner selection and notification:** Winners of the Contest will be selected by a judging panel of up to ten judges selected by the Sponsor. Entries will be evaluated based on the utility, elegance and ease of use of the template. Winners will be notified via email to the account they entered the Contest with, within five (5) days following their selection.

Sponsor shall have no liability for a winner's failure to receive notices due to winners' spam, filter, or other settings or provision of incorrect or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 15 days from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited, and an alternate winner(s) selected.

The receipt by winner of the prize offered in this Contest is conditioned upon compliance with any and all federal and state laws and regulations. ANY VIOLATION OF THESE OFFICIAL RULES BY ANY WINNER (AT SPONSOR'S SOLE DISCRETION) WILL RESULT IN SUCH WINNER'S DISQUALIFICATION AS WINNER OF THE CONTEST AND ALL PRIVILEGES AS WINNER WILL BE IMMEDIATELY TERMINATED.

Rights Granted by you:** By entering this content you understand that Sponsor, anyone acting on behalf of Sponsor, or its respective licensees, successors and assigns will have the right, where permitted by law, without any further notice, review or consent to print, publish, broadcast, distribute, and use, worldwide in any media now known or hereafter in perpetuity and throughout the world, your entry, including, without limitation, its contents including images, and winner's name, portrait, picture, voice, likeness, image

or statements as publicity or information and for trade, advertising, and PR purposes without any further compensation.

- 8. Terms:** Sponsor reserves the right, in its sole discretion to cancel, terminate, modify or suspend the Contest should (in its sole discretion) a virus, bug, non-authorized human intervention, fraud or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Contest. In such case, Sponsor may select the recipients from all eligible entries received prior to and/or after (if appropriate) the action taken by Sponsor. Sponsor reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Contest or violates these Terms & Conditions.

Sponsor has the right, in its sole discretion, to maintain the integrity of the Contest, to void votes for any reason, including, but not limited to; multiple entries from the same user from different IP addresses or email accounts; multiple entries from the same computer in excess of that allowed by Contest rules; or the use of bots, macros or scripts or other technical means for entering.
